We collect information from you when

We obtain information about you when you access our website, if you sign up to receive our email newsletter, if you voluntarily choose to provide us with your details during registration, and if you make an online reservation.

How your information is used

Our use of your personal data will always have a lawful basis. Your data will be used because you have consented to our use of your personal data and because it is in our legitimate interests. We require your details to understand your needs, provide you with a better service, improving our products and services, and for sending marketing communications if you have opted in to receive them.

What type of information is collected?

When you sign up for our Email Newsletters we may collect your title, name and e-mail address.

When you access our websites information collected may include device type (e.g. mobile, computer, laptop, tablet) operating system, IP address, browser type, browser information domain names access times settings, generic location.

When you make an online reservation consent is given for Green Tree Adventures to use the necessary information to carry-out the booking process. All customer details are used solely to facilitate efficient booking, payment, refund, and fraud prevention process. In addition we occasionally send out a short email reminder of the services on offer. At no time are any personal details shared, transferred or sold to other third parties. Children

Who has access to your information?

We will not sell, distribute, or lease your personal information to third parties. Any personal information we request will be safeguarded under current legislation.

Your personal data will be kept for as long as it is needed in order to use it as described in this privacy policy, and/or for as long as we have your permission to keep it. Personal data can be deleted on request.

Your choices

You have a choice about whether or not you wish to receive information from us. We will not contact you for marketing purposes by email unless you have given your prior consent. We will not pass your details to any third parties for marketing purposes.
